A message from our Associate Executive Director & Chair

As we look back on 2023/2024, it's hard to imagine it's been a full year since moving into our new main office location. As you walk the halls, you hear the hustle and bustle of amazing JHS colleagues working alongside clients, the walls and spaces are decorated with clients' works of art and other meaningful décor, and tenants of our Carling Residence are easing into their new home. The environment is warm and welcoming for our colleagues and clients alike, and it is evident that everyone is now settling into this beautiful new space.

We've marked an exciting year as we enter the implementation phase of our new strategic vision for 2023 through 2028. There is incredible momentum in continuing to action our priorities of A Well Workplace, A Culture of Belonging, and Intentional Growth, Service Innovation and Sustainability. We want to thank our colleagues who are involved, through committees and by other means, in animating this work and bringing our strategic priorities to life. This would not be possible without your commitment and sharing of your time and talents.

A new addition to A Well Workplace is the implementation of the National Standard of Canada for Psychological Health and Safety in the Workplace. Clear action steps are underway to continue our efforts towards a workplace that is both mentally healthy and supportive. This work comes at a crucial time as our service-providers face growing complexity in their roles as our service-seekers are coming to us with more acute and complex needs than ever before. Through our Culture of Belonging priority, we continue to advance our Diversity, Equity and Inclusion efforts, and this year brought a commitment to commence our agency Reconciliation Plan. Discussions with the Board and Management Team have begun, and we look forward to this incredibly important undertaking in the year ahead.

The agency added another housing program to our portfolio when we opened our newest supportive housing for women. Through funding from the federal government's Rapid Housing Initiative, this 29-unit apartment building finalized construction, and women started moving into their new home in late winter of this year. This warm and welcoming four-storey building incorporates Indigenous cultural elements into the structure and design with authenticity and appropriate care. This location is an intentional space created for women, with a commitment that 70% of those who make a home here will be Indigenous. We are grateful for our partnership with Minwaashin Lodge, and look forward to learning and living into this new space.

Lastly, as this year came to an end, we learned that our Executive Director, Tyler Fainstat, was moving on to an incredible opportunity in British Columbia. I think we can speak on behalf of all Board and staff when we say this was hard news to hear. Tyler has been a profoundly impactful leader in his eight-year tenure, and embodied our values and beliefs in his leadership like no other. Tyler is caring, compassionate, humble, and an all-around incredible human being. Even though his time with JHS Ottawa felt short-lived, Tyler will leave a long-lasting impression on the agency and the Ottawa community. We thank you, Tyler, for your unwavering commitment to our colleagues and clients, and wish you nothing but success in your new adventures at John Howard Society North Island.




