


# THE COMPLEX WEB OF REINTEGRATION



## BY THE NUMBERS

The **RECIDIVISM RATE** for individuals leaving Ontario's correctional facilities after 6+ months is **37.4%**

Over **50%** of individuals in correctional institutions are under the **AGE OF 35**

**78%** of total incarcerated in Ontario serve custodial sentence of **3 months or less**

In Ontario **64.5%** of individuals in custody are on **REMAND** (awaiting trial)

**1/2** of all individuals in correctional services across Canada are in **ONTARIO**
